For the supply of all digital files & images

CLIENTS please note - by accepting and using the digital image(s) / file(s) that are supplied to you by ironwill photography you agree to these following terms and conditions.

Engaging ironwill photography

Ironwill photography offers a commercial digital imaging service.

By engaging ironwill photography for the supply of commercial photography (whether digital or film), the engaging party(s), agent of the party(s), chattel or property owner(s) are **not** purchasing the ownership or copyright of the supplied digital image files or prints.

Ownership and Purpose

Digital image files supplied can only be used for the original marketing campaign / purpose as was disclosed to ironwill photography by the original real estate Agent(s), Agency('s) or client(s) or vendor of the property.

These digital files are not transferable in any form or manner, or in part by any means to any other party or individual, without the written consent of the copyright owner, Will S Zyle - ironwill photography.

There is no implied or actual release of any copyright or other rights that current Australian & International copyright law affords or offers the copyright owner. All rights are reserved. All supplied digital image files - remain the property of Will S Zyle - ironwill photography.

The copyright owner shall not be liable for any action or claim for remedy or damages from any party. Whether the claim is a result arising from any use or misuse of the digital image files supplied to clients within any form or media whether those digital image files were authorised or not.

Licensing & Usage of Digital image files

Clients or any authorised other parties, simply by receiving the digital files whether directly from ironwill photography or any other party whether authorised or not and by any form or means, does not automatically grant you the right or permission to use the digital image files in any way you wish. No party or individual has implied or actual permission to manipulate, alter, transfer or supply the digital image files to any other parties. The original party to whom the digital image files were supplied are licensed to use the supplied digital image files for the original purpose as disclosed to the copyright owner for a period of 18 months from the photography session date.

This license applies as a single commercial purpose / application only. The digital image files are supplied to client(s) for the original purpose intended and not to third parties or individuals without express written permission from the copyright owner. This license cannot be transferred to any other individual(s) or party(s) without written permission from the copyright owner.

Bookings & Payment

All photography bookings are confirmed with ironwill photography on a commercial service hire basis only.

No booking is accepted as an assignment and in the absence of a written agreement clearly stating the terms and conditions of an assignment, all bookings are on a commercial hire basis. Therefore ironwill photography retains all rights and copyright to all digital image files produced and supplied to client(s) or other party(s) without exception. Refer [Australian Copyright Council](#) or [4Clients - ACMP](#).

The above usage and licensing rights are conditional on the basis that full payment of invoices supplied is made within the stated trading terms. Usage of digital image files outside of these terms breaches copyright.

Invoices must be paid in full as per the terms stated on the invoice supplied. All invoices supplied by ironwill photography are (x) number of days from date of invoice for due date for payment. If full payment is not made as per the stated terms, debt collection will be initiated. Debt collection costs & legal fees incurred by ironwill photography for the recovery of the outstanding funds will be added on top of the outstanding invoice amount(s).

Protecting digital image files

All digital image files supplied contain extensive metadata tags and information. This digital information is embedded into each digital file. Some files also contain an embedded watermark that is invisible. Please be aware that some digital image files supplied by ironwill photography may be registered with international copyright protection databases and are regularly trawling the internet looking for illegal use of images. Most of these protective measures are impossible to detect or alter on the digital file without the access protocols.

Things you CANNOT do

All digital image files supplied cannot be digitally enhanced, manipulated, edited or altered in any way or by any means. Also, the embedded metadata visible or invisible cannot be removed, altered or manipulated without the express written permission from the copyright owner. A digital image file(s) and the resulting image that is formed by printing, visual display on a computer screen, opened or resaved, commercially applied or printed is considered an original work. It is also deemed as intellectual property. As such it is therefore property that is owned - using a digital image file illegally is THEFT.
